RESOLUTION FOR SPEED LIMIT REDUCTION ON SHERWOOD RD.

At a regular meeting of the Town Board of the Town of Ledyard, Cayuga County, New York, held at the Town of Ledyard, 1099 Poplar Ridge Rd., Aurora, NY, 13026 on

June 14, 2021 at 7:30pm the resolution was approved.

WHEREAS, in October 2018, The Town of Ledyard approved The Inns of Aurora, Spa development at 700 Sherwood Rd., Aurora.

WHEREAS, in 2020, The Inns of Aurora Community Trail crosses over a 55mph zoned Sherwood Rd to the west of The Spa.

WHEREAS, Residents of the community have expressed concern for the current speed limit of 55mph along with the amount of traffic from the Inns of Aurora, Spa to The Village of Aurora and vice versa.

WHEREAS, The Town of Ledyard has approved a decrease in the speed limit on Sherwood Rd., Aurora, Town of Ledyard, County of Cayuga, State of New York.

WHEREAS, The speed limit will decrease from 55mph to 45mph at approx. 2,000' to the West of Sands Rd. on Sherwood Rd. and from 45-30mph at the East driveway of the Inns of Aurora Spa and continue approximately 4,000' to the Village of Aurora line.

NOW, THEREFOR BE IT RESOLVED, BY THE TOWN BOARD OF THE TOWN OF LEDYARD, CAYUGA COUNTY, NEW YORK that;

Section 1. The Town of Ledyard supports the speed reduction on Sherwood Rd.
